## PRESENTATION

This workshop explores the qualitative determinants of informal work, focusing on economic vulnerability, legal consciousness, institutional trust, political legitimacy, regulatory burden, cultural norms, and the blue economy. Moving beyond conventional quantitative indicators, it examines how perceptions of fairness, compliance culture, social acceptance and livelihood strategies shape informal practices across sectors, territories and national contexts.

The workshop also addresses methodological challenges in researching hidden forms of informality, including interviews, vignettes, perception scales, indirect questioning and mixed methods approaches aimed at incorporating non-observable variables into the INSEAI Model. Contributions from economics, law, sociology, political science, anthropology, labour studies, gender studies, psychology and related fields are welcome.

- Political institutions, enforcement and state-citizen reciprocity.
